# Hagiography Society Sessions at Kalamazoo: CFPs

#### **Holy Marketing**

Medieval tombs, shrines, and sacred spaces were often crafted through the collaborative efforts of a network of agents. In competitive religious environments, ecclesiastical and secular figures who managed such holy sites drew profit from the contributions of pilgrims, and often found themselves in competition for the same "business" of attracting these visitors. They worked to imbue a site with the holy attributes of a particular saint, transforming it into an important nucleus of social and economic activity. In this way, these sites and objects became "material hagiographies" that attracted pilgrims and devotees in similar and dissimilar manner to textual hagiographies. The papers in this session will examine this material "genre" of hagiography and its socioeconomic influence.

The Golden Legend and the Standardization of Sanctity

On the occasion of the 720<sup>th</sup> obit anniversary of Jacobus de Varagine (d. 1298), this panel will engage multiple threads of inquiry surrounding his production of *The Golden Legend*. In particular, we wish to examine how the compilation affected hagiographic practice and saintly representation. For an interdisciplinary panel that will involve discussion of manuscripts, texts, liturgy, and artistic programs, we ask: how did *The Golden Legend* shape models of individual saints and of late medieval sanctity more generally? Can we detect moments of resistance to hagiographic standardization? How does the political, religious, and cultural context of Jacobus's world in thirteenth-century Liguria shape our understanding of his compilational logic?

### Beyond Delooz: Sanctity Individual and Corporate

Sanctity, as Pierre Delooz argued long ago, is a collaborative construct. Yet just as all saints are constructed by a community, to use his classic formulation, they also function as individual exemplars of a sanctity uniquely situated within a nexus of localized, gendered, and politicized concerns. This panel seeks new work on the intersectional nature of of sanctity—specifically, on the relationship between individual and corporate sanctity. It invites papers to reconsider Delooz' influential formulation of constructed sanctity by interrogating the very nature of that construction in different contexts of sanctity and cultures of holiness. It asks: who or what constructs a saint. and how does that construction balance and encompass both individual and corporate concerns? How does individual subjectivity—of the saint and/or the community member—intersect with its collaborative construction?

What is the relationship between collective memory and individual subjectivity? How do the texts and literature that codify sanctity reflect, generate, and even instantiate both the collaborative construction of the saint as well as an individual saint—and to what ends and/or purpose? And finally, how does the materiality and textuality of sanctity seek to construct individual holiness through corporate literacy?

The Institute of History, University of Warsaw, is seeking to recruit a post-doctoral researcher for a position in the project The Cult of Saints: a Christendom-wide study of its origins, spread and development. The Project is supported by an Advanced Grant from the European Research Council under Grant Agreement Number 340540 and is based at the University of Oxford with a partnership at the University of Warsaw. The successful candidate will work as part of a team of seven post-doctoral researchers reporting to the Principal Investigator, Prof. Bryan Ward-Perkins (University of Oxford), but under direct supervision of Dr. hab. Robert Wiśniewski (University of Warsaw). The postholder will have responsibility for collecting Latin evidence consisting mostly of literary texts, within an electronic searchable database. The postholder is also expected to produce sole-authored articles on aspects of the cult of saints in the West.

This is a full-time time position for 12 months, starting on 1 November 2017 or soon thereafter. The postholder will be offered the salary of about 2 700 Euros per month.
