Journal of Medieval Religious Cultures, special issue on Race and Religion, submissions due May 15, 2021.

Recent scholarly interrogations of race in the Middle Ages offer a much-needed intervention into the Eurocentrism of medieval studies. However, little published scholarship to date has focused explicitly on the intersections of race and religion. This special issue of the JMRC invites essays that examine any aspect of race and religion in medieval culture and society.

Possible topics include the role of race in the formation of religious identity; discourses of race in medieval theology; representations of race, including the imagining of racialized "others," in religious literature; and encounters across differently raced or racialized religious traditions. How, we might ask, are racialized and religious discourses mutually constitutive? How do they work against each other? What are the various roles of race and ethnicity (one's own, or that of the imagined "Other") in religious self-formation? How does race figure into devotional, contemplative, or meditative practice? Such questions open up new avenues of research and challenge us to examine more closely the subtle and pervasive uses of racialized discourses to create religious identity.

The *Journal of Medieval Religious Cultures* welcomes article submissions from 5,000-10,000 words in length. Articles should be submitted through our online system at http://www.editorialmanager.com/jmrc by May 15, 2021, with a cover letter indicating that they are intended for the special issue. All submissions will follow our usual double-blind peer-review process. The issue is tentatively scheduled to be published in summer 2022.
